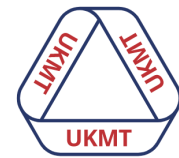

1. Purpose and scope of this cookie notice

1.1 This cookie notice explains how we use cookies on our website at <https://www.ukmt.org.uk> and is intended to assist you in making informed decisions about using our website.

1.2 Our website contains links to other websites. Our cookie notice applies only to our website so if you click on a link to another website then you should read its cookie notice.

2. Definitions of terms used in this policy statement

2.1 What are cookies?

Cookies are text files placed on your computer to collect standard internet log information and visitor behaviour information. When you visit our website, we may collect information from you automatically through cookies or similar technology.

3.1 UKMT are committed to good practice in the handling of personal data and compliance with the requirements of the [Data Protection Act \(2018\)](#).

3.2 UKMT will seek to give individuals as much choice as is possible and reasonable over what data is held and how it is used.

4. Procedures

4.1 What do UKMT do with cookies?

Essential cookies

UKMT use cookies where they are essential for the operation of our website, for example to remember that you are signed in to the website, to provide security for online payments or to prevent malicious attacks.

UKMT uses cookies to allow the website to uniquely identify your browsing session on our website, which allows us to coordinate this information with data from our website server.

Analytics cookies

These, along with other information, allow UKMT to calculate the aggregate number of people using our website and which features and content are most popular. UKMT use this information to improve the website.

4.2 What cookies do we use on our website?

Google Analytics	No	Set by Google to track website usage. https://developers.google.com/analytics/devguides/collecton/analyticsjs/cookie-usage

4.4 What happens when you refuse, block or delete cookies?
